"To all people to whom these presents shall come know ye that I JOHN BUNTIN of Pitt County and State of N° Carolina sends greeting in our Lord God everlasting. Know ye that I JOHN BUNTIN for and in consideration of the love and affection I have and bear to my Son GARLDESS BUNTIN and for the consideration of the Sum of five Shillings to me in hand paid before the unsealing and delivering of these presents and for his b____r[?] adv___[?] and preferment[?] in the world have given granted and conferred and by these presents do fully freely and absolutely give grant and conferred unto the said GARLDRESS BUNTIN and his Heirs and Assigns for ever a certain peace or parcel of Land given to ELSEY AVRETT by her Aunt ELISABETH OLDSHE to have and to hold the aforesaid land and premises unto the said GARLDRESS BUNTIN his Heirs and Assigns for ever and I the said JOHN BUNTIN so warrant the said Land and premises unto the said GARLDRESS BUNTIN and his Heirs and Assigns forever In witness whereof the s^d JOHN BUNTIN hath hereunto set his Hand by Seal this 29th September 1792.
